WE STONGLY PROTEST THE CONSTRUCTION OF ANY ADDITIONAL ANTENNA AND WANT THE EXISTING ONES THAT DON'T MEET THE CODE TO BE REMOVED. CERTAINLY, NO VARIANCE SHOULD BE ALLOWED SINCE THIS WOULD SET AN UNACCEPTABLE PRECEDENT FOR OTHER NEIGHBORHOODS. NOT ONLY ARE THE TOWERS AN EYESORE, THEY COULD ALSO BE A SAFETY HAZARD FOR WILD ANIMALS, LOOSE DOGS, AND/OR CHILDREN WHO MAY BECOME ENTANGLED IN THE MESS OF WIRING AND METAL STRUCTURES.
