I, The undersigned Me Jean-Marie Hiest attorney for Maître Canet in Zandian judiciary liquidation (Bankruptcy Proceedings n°989252) under oath hereby declare and confirm that per French liquidation law *n° 85-98 au 25 janvier 1985 relative au redressement et à la liquidation judiciaires des entreprises (applicable to Zandian's liquidation)*, Mr Margolin is not a creditor recognized in the Zandian liquidation proceeding.

I have personnel knowledge of the matters pertaining to the Zandian liquidation.

Under the French laws governing liquidation (L. n°85-98), a creditor is required to assert a claim by filing such a claim with Court administering the liquidation (L.64, L.40 and D.61)

Il have checked the registry of claims against Zandian and Jed Margolin (Monsieur Margolin) has not filed a claim in the Zandian liquidation proceedings.

Accordingly, Mr Margolin is not on the list of recognized creditors in the Zandian liquidation proceeding.

Under French liquidation laws, Mr Margolin has no recognized, enforceable claim against the Zandian liquidation estate. To be effective under French law, any claim pursued against Zandian by Mr Margolin would have required naming Maître Canet (L.40 « debt arising irregularly »).
